### Waiver/Release of Liability:

- Bird River Bible Camp is a Christian camp and a ministry of Southland Church which exists to teach campers the Bible in accordance with Southland's beliefs and practices.
- Bird River Bible Camp reserves the right to dismiss a camper, who in the opinion of the camp, is a hazard to the safety of themselves or others, which includes dismissal for medical reasons (ie. Illnesses or injury which remove the camper from daily activities).
- Bird River Bible Camp reserves the right to dismiss a camper, who in the opinion of the camp, has rejected the reasonable controls (basic guidelines) of Bird River Bible Camp.
- Undersigned assures that camper is normal in habits and amenable to necessary discipline and will notify camp office otherwise. Camp reserves the right to not accept a camper if there is not the possibility of being able to provide for acceptable care of child as deemed by the camp.
- Southland Church and Bird River Bible Camp's directors, staff, officers and volunteers are hereby released from any liability in the event of illness, accident or misfortune of the registered camper. Each camper must have Provincial or equivalent medical coverage. Undersigned gives the director the right to act in place of a reasonable parent to acquire special medical attention or other requirements for the medical well-being of the camper. The undersigned will be responsible for any costs involved.
- All medication must arrive at camp with sufficient supply. All medication will be administered by the Camp Medical Professional, NOT the camper.
- Undersigned gives the Camp Medical Professional permission to administer non-prescription drugs such as aspirin, for the medical well-being of the camper. Any changes in medical history must be reported within 4 weeks of camp session.
- All video or photographs taken by Bird River Bible Camp and Southland Church at Bird River Bible Camp are the property of Bird River Bible Camp and Southland Church and may be used for promotional purposes. **RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT**

**BY SIGNING THIS DOCUMENT, YOU WILL WAIVE OR GIVE UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM**

**COMPENSATION FOLLOWING AN ACCIDENT**

**TO:** Bird River Bible Camp and their respective directors, officers, employees, agents, representatives, independent contractors, subcontractors, sponsors, successors and assigns (all of whom are hereinafter referred to as ( "the RELEASEES" )

**ASSUMPTION OF RISKS:** I am aware that my child may be participating in water activities which may include the following activities listed. Water skiing, wake boarding, tubing, playing on inflatable's, and or water vessel operations involves many inherent risks, dangers and hazards, including, but not limited to: boarding, riding in and disembarking boats; changing weather conditions; exposed rock, sandbars or other natural or unnatural objects; changes in the condition and quality of water; changes or variations in the water surface, including changes due to man-made or artificial influences such as boat wakes and storms; impact with other boats, docks or other structures, objects or equipment used in connection with water skiing, wake boarding, tubing, playing on inflatable's, and or operating water vessels; impact or collision with other water skiers, wake boarders, tubers, and or other water vessels; storms; the failure to water ski, wake board, tube, and or operate water vessels safely or within one's own ability; negligence of other skiers, wake boarders, tubers, and or water vessels; NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGAURD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS. I am aware that the risks, danger and hazards referred to above exist throughout the water ski, wake boarding, tubing, inflatable's, and water vessel area of operation and most are unmarked. I freely accept and fully assume all risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting therefrom.

**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:** In consideration of Bird River Bible Camp accepting my application to participate in any watersport activities, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I may have or may in the future have against THE RELEASEES and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer as a result of my use of the Facilities and Services DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR ANY OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARF OWNED UNDER THE OCCUPIERS LIABILITY ACT, R.S.B.C. 1996, c. 337, ON THE PART OF THE RELEASEES, AND INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGAURD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE.
2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to the property of, or personal injury to, any third party resulting from my use of the Facilities and Services; and
3. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Manitoba and no other jurisdiction; and
4. Any litigation involving the parties to this Release Agreement shall be brought solely within the Province of Manitoba and shall be within the exclusive jurisdiction of the Courts of the Province of Manitoba.
5. This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity.

In entering into this Agreement, I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this Agreement.
